- Weave has Zero Data Retention agreements in place with all LLM providers that may contact customer data.
- Weave does not permit machine learning/training on any customer data, nor does it permit its vendors to.
- Weave follows industry-best security and privacy practices. Details are available upon request and Weave is happy to complete customer IT questionnaires and vendor approval processes.
- Role-based permissions and access control are available in the Weave platform.
